The starting dates are approximate values depending on the Contractors planning. The duration will be 2 to 3 weeks per unit and will be depending on extent of the pre-stressing. No adjustment to the Time for Completion is applicable as Works for all Units are already taken over.

Additionally, the Employer shall compensate the Contract 2 additional mobilizations at their actual costs based on time sheets.

The actual costs of manpower will be invoiced based on the actual time recorded on time sheets at updated man-hour rates for 2023 (see Contractor's letter 230829\_RIGA-GE-LE-23-011 from 29 of August, 2023)
